## MEMORANDUM

**INRE:** Qualifying for the **2010 LPGA STATE FARM CLASSIC**

According to the Ladies Professional Golf Association's rules of competition, a field for an LPGA tournament is considered full at 144 participants. Inclusive in their field are two spots, which may be filled by qualifiers based on the following series of steps:

### **Sunday, June 6 - Amateur Qualifying (8:00 A. M. – Panther Creek Country Club)**

**Your handicap must be a verified 2.0 or less** and that verification must be sent along with the registration form and entry fee **NO LATER THAN 5:00 P. M. MONDAY, MAY 24<sup>th</sup>** to the State Farm Classic, 2375 West Monroe, Suite 320, Springfield, IL 62704.

The two low scores will have the opportunity to either (1) advance to the Monday Professional Qualifying Round (which will be played if the field is full and there are nonexempt and/or conditional professionals who wish to have an opportunity to qualify for the tournament), or (2) be added to the field if the professional field is not full.

There will be a **\$75 entry fee** to participate in this round (should it be necessary for you to play in the Monday Professional Qualifying Round this entry fee also covers that round. If you qualify for the Tournament, you will pay an additional \$150 to enter, plus \$30 will be charged for insurance).

### **IF NEEDED - Monday, June 7 - Professional Qualifying (1:00 P. M. – Panther Creek Country Club)**

**NO MORE THAN 2 AMATEURS MAY PARTICIPATE IN THIS QUALIFYING ROUND WITH PROFESSIONALS.** The 2 low scores from the Sunday Amateur Qualifying will advance. If there are no professionals needing to qualify, there will be no Monday round. Before you leave the course on Sunday, you will be notified as to the status of the Monday round.

**NOTE: Per the LPGA regulations - A score of 88 or higher may not advance into the Monday Qualifier even if it is one of the two lowest scores.**
